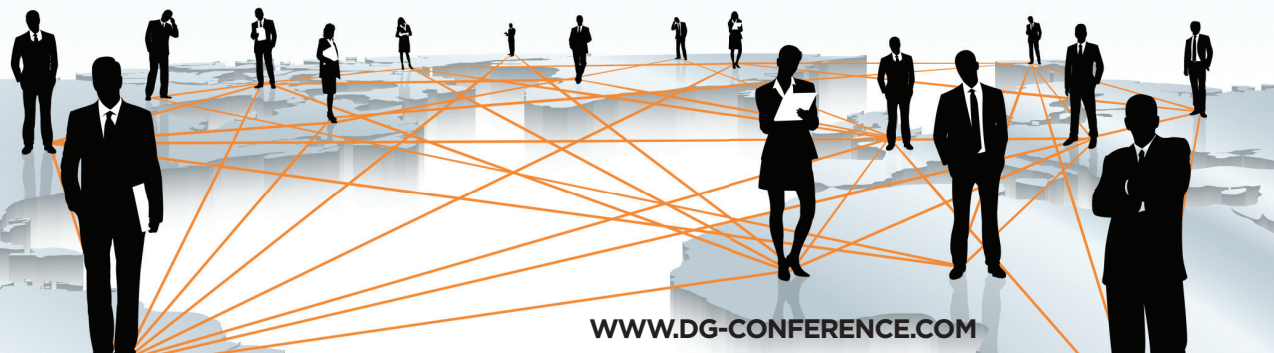

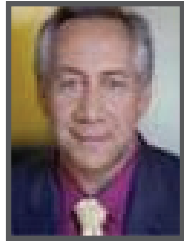

THE “WICKED CHALLENGE” OF DATA GOVERNANCE

The practice of data management is complex but fairly straightforward. Truth is, our business clients are kind of surprised that us data – types approach this as a new thing. There is a set of common “elephants in the room” that data governance and data quality groups try to side step. But they are normal resistance patterns and can be managed, and even leveraged.
